All undertakings and documents mentioned in the application checklist for local and international students should be completed as per the deadlines, inability to complete before the deadline will result in cancellation of conditional admission.
- Convocation fee of AED 4,250/- + VAT 5% will be additional payable in the final year of the program.
- Transportation fee is additional, refer miscellaneous fees.
- For all payments against Tuition fees and miscellaneous fees refer to SUC Financial Policy 2024-2025.
- The students under the Youth empowerment sponsorship fee structure adhere to the monthly payment plan per year for the duration of the program irrespective of his/her registration in the summer intake.
- Youth empowerment sponsorship enables/provides the benefit for the student to have lower monthly installments, which are spread over 12 installments per year for the duration of the program.
